(a) Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals

The small section of wire on the floor in front of the self feeders of several of the elevated cribs is coming loose from the floor. The loose wire has sharp edges and is a potential area of injury for the animals. These areas need to be repaired or replaced to prevent injury,

OUTDOOR HOUSING FACILITIES.

(a) Acclimation. Only nonhuman primates that are acclimated, as determined by the attending veterinarian, to the prevailing temperature and humidity at the outdoor housing facility during the time of year they are at the facility, and that can tolerate the range of temperatures and climatic conditions known to occur at the facility at that time of year without stress or discomfort, may be kept in outdoor facilities.

Currently, cynomologous macagues are housed in outdoor enclosures with heat available during the cold weather. Review of medical records indicate that there is an on going problem with frost bite on the tails or many of these animals each winter. At time of the inspection, construction has begun on 3 of 10 buildings to house this species. The new housing will provide adequate winter heat .

All Cynomologous macaques must be provided with housing which will provide protection from cold weather .
