Re: Pigs Allegedly Freezing to Death at Smithfield Fresh Meats Corp. in Crete

Dear Messrs. Organ and Leeth:

**Your attention is urgently requested.** This letter concerns a recent report submitted to PETA's headquarters by an individual who claims to have knowledge of pigs suffering from severe frostbite and freezing to death at Smithfield Fresh Meats Corp. (est. M717CR + P717CR) in Crete, Nebraska.

We've been told that upon arriving at the plant, pigs are being left on transport trucks for hours. The insulating panels on the vehicles are reportedly ineffective in the current cold, and the animals evidently suffer from extreme frostbite and even freeze to death as a result. Once unloaded, they're then allegedly left in unheated barns before slaughter.

These allegations, if true, could constitute violations of Nebraska law, which prohibits "intentionally, knowingly, or recklessly abandon[ing] or cruelly neglect[ing] a livestock animal." Clearly, the alleged circumstances do not conform with the commonly accepted practices of commercial livestock operations, which are otherwise exempt from prosecution.

Given the extreme cold forecast for Crete this week, we hope to receive your prompt assurance that Smithfield Foods will immediately investigate how long pigs are being held on trailers and in barns at the facility and take all necessary steps to prevent them from suffering from frostbite and dying during or following transport to this facility.
