ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Daily observation of all animals to assess their health and well-being; Provided, however, That daily observation of animals may be accomplished by someone other than the attending veterinarian; and Provided, further, That a mechanism of direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian.

- 1. While conducting this inspection it was noted that one of the ring tailed lemurs was injured. This lemur was non weight bearing on its back, left leg. There was also a wound to its right thigh. The wound on the thigh appeared to be new evident by the fresh blood that was around the area. This animal was pulled from the enclosure, while we were present, and placed into a Vari kennel. The attending veterinary was called. This animals condition will need to be evaluated by the attending veterinarian.

- 2. While conducting this inspection we were informed that their elderly, female, chimp had passed way in April. In discussing this situation with the owners it was determined that this chimp had been showing behavioral changes for a few days before the final episode. Once this animal was obviously ill the veterinary was called. However, the animal passed before the vet was able to make it to the facility. Frequent communication is required so that timely and accurate information on problems of animal health and behavior is conveyed to the attending veterinarian. Should other animals show behavioral changes the attending veterinarian will need to be called in a more timely manner.

- (i) The name and address of the person from whom the animals were purchased or otherwise acquired;

PRIMARY ENCLOSURES.

Primary enclosures must be designed and constructed of suitable materials so that they are structurally sound for the species of nonhuman primates contained in them. They must be kept in good repair.

- (2) Primary enclosures must be constructed and maintained so that they:
- (i) Have no sharp points or edges that could injure the nonhuman primates;
- (ii) Protect the nonhuman primates from injury
- The ring tail lemur enclosure has a metal framed platform that is under a wooden den box. The left side of the
 metal platform has broken apart. The platform is now loose and sagging. To ensure the integrity platform, and the
 safety of the den box, this will need to be addressed.
- ***To Be Corrected By: June 8, 2013
- 2. There was an extension cord that ran along the outside of the lemur pen. This cord was used to power the heat lamp in the lemur's den box. However, the cord had been pulled taunt and was right up against the primary fencing. The lemurs had direct access to this electrical extension cord that was obviously "live". To ensure the safety of the lemurs this cord will need to be addressed.
- ***To Be Corrected By: May 31, 2013 This was corrected before we left the premise

FACILITIES, GENERAL.

The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.

- The tiger's wood den / shelter box is in need of attention. The front panel of the shelter box had sections of peeling paint. To ensure the safety of this tiger, these areas will need to be addressed.
 To Be Corrected By: June 30, 2013
- 2. The back, right corner of the carnel pen is also in need of attention. The chain link fence has detached from a few of the staples that held the fence to the support post. There is now a gap between the chain link fence and the post along the bottom half of the pole. To ensure the integrity of the fence this area will need to be addressed.
 ***To Be Corrected By: June 8, 2013
- The roof of the calf shelter is in need of attention. The wood shingles have begun to deteriorate and are now jagged. To ensure that this roof is in good condition it will need to be addressed.
