One giraffe was observed with overgrown hooves. Hooves need to be trimmed to prevent discomfort and development of abnormal gait. Owner stated that hoof trimming is scheduled to occur prior to planned transport with next 2-3 weeks. Correct by April 30, 2014.

RECORDS: DEALERS AND EXHIBITORS.

Several records of acquisitions/dispositions were missing and not up to date. There are no records for five kangaroos, 3 African porcupines, one camel baby, and one giraffe baby. There is no records for one missing giraffe and one missing zebra. There is no record for one newly acquired Grevy zebra. Need to keep all records current including births and deaths and all transactions so that records match animals actually present. Correct by April 15, 2014.

HANDLING OF ANIMALS.

Several members of the public were observed feeding and petting the miniature zebu and llamas in the front pasture without an attendant present. No attendant was observed anywhere in the walk-thru portion of the zoo. Also, one adult was observed putting his small child on the roof of his car next to the giraffe exhibit so the child could feed the giraffe. No attendant was present in this area. Employee escorting inspectors did stop and tell the man to stay in his car, however a readily identifiable attendant should be present during any public contact in order to prevent harm to the animals and the public. Correct by April 15, 2014.

ENVIRONMENT ENHANCEMENT TO PROMOTE PSYCHOLOGICAL WELL-BEING.

Eight ringtail lemurs housed temporarily in the rhino barn had only a perch for enrichment. One male was singly housed for incompatibility and did not have any enrichment present. Environmental enrichment plan was not available for review. Need to keep enrichment plan available for review and provide adequate enrichment for all primates even while in temporary quarters to prevent development of abnormal behaviors. Correct by April 15, 2014.
