



### CITATION AND NOTIFICATION OF PENALTY

We believe that you violated the Animal Welfare Act (7 U.S.C. § 2131 et seq.) (AWA), as described below.

# Date of Violation: April 11 and 12, 2012

9 C.F.R. § 2.1(a)(1) Requirements and application. (a)(1) Any person operating or intending to operate as a dealer, exhibitor, or operator of an auction sale, except persons who are exempted from the licensing requirements under paragraph (a)(3) of this section, must have a valid license.

You operated as an exhibitor without a valid license. You produced an episode of "Call of the Wildman" titled "Baby Mama Drama" that featured an adult raccoon and three raccoon kits which were filmed for exhibition purposes.

# Date of Violation: On or about May 26, 2012

9 C.F.R. § 2.1(a)(1) Requirements and application. (a)(1) Any person operating or intending to operate as a dealer, exhibitor, or operator of an auction sale, except persons who are exempted from the licensing requirements under paragraph (a)(3) of this section, must have a valid license.

You operated as an exhibitor without a valid license. You produced an episode of "Call of the Wildman" titled "Sawmill Slasher" that featured two North American porcupines which were filmed for exhibition purposes.

#### Date of Violation: September 12 and 17, 2012

9 C.F.R. § 2.1(a)(1) Requirements and application. (a)(1) Any person operating or intending to operate as a dealer, exhibitor, or operator of an auction sale, except persons who are exempted from the licensing requirements under paragraph (a)(3) of this section, must have a valid license.

You operated as an exhibitor without a valid license. You produced an episode of "Call of the Wildman" titled "Deer Destruction" that featured a white-tailed deer and two raccoons which were filmed for exhibition purposes.

# Date of Violation: On or about September 12, 2012

9 C.F.R. § 2.131(b)(1) Handling of animals. (b)(1) Handling of all animals shall be done as expeditiously and carefully as possible in a manner that does not cause trauma, overheating, excessive cooling, behavioral stress, physical harm, or unnecessary discomfort.

You failed to ensure that animals were handled as expeditiously and carefully as possible. You filmed a Kentucky Nuisance Wildlife Control Operator named **b6 & b7c** for an episode of "Call of the Wildman" titled "Deer Destruction." You filmed a farm-raised white-tailed deer inside a shop, causing it unnecessary discomfort and stress.

# Date of Violation: March 24 and April 8, 2013

9 C.F.R. § 2.1(a)(1) Requirements and application. (a)(1) Any person operating or intending to operate as a dealer, exhibitor, or operator of an auction sale, except persons who are exempted from the licensing requirements under paragraph (a)(3) of this section, must have a valid license.

You operated as an exhibitor without a valid license. You produced an episode of "Call of the Wildman" titled "Bat Hair Day" that featured Mexican free tailed bats and a raccoon which were filmed for exhibition purposes.

### Date of Violation: On or about April 18, 2013

9 C.F.R. § 2.1(a)(1) Requirements and application. (a)(1) Any person operating or intending to operate as a dealer, exhibitor, or operator of an auction sale, except persons who are exempted from the licensing requirements under paragraph (a)(3) of this section, must have a valid license.

You operated as an exhibitor without a valid license. You produced an episode of "Call of the Wildman" titled "Lone Stars and Stripes" that featured five armadillo which were filmed for exhibition purposes.

#### Date of Violation: May 10, 2013
