ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

The written Program of Veterinary Care (PVC) is out-of-date. The veterinarian who signed the PVC in 2010 has moved out of the area, and the provisions for annual preventive care described in the PVC are not being followed by the exhibitor.

The exhibitor should work with an attending veterinarian to create a new written Program of Veterinary Care that describes husbandry, preventive, and other care practices for the animals on hand, and this plan should include provisions for regular veterinary care as needed, and a review of the written PVC by the exhibitor and attending veterinarian at least once a year.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Three llamas and 2 camels have overgrown hooves. An excessive hoof length can cause an animal to stand and walk abnormally. Abnormal posture and gaits may cause strain on joints and may be accompanied by possible pain and/or discomfort and joint damage. A system should be in place to identify animals that are in need of hoof trimming and provide trimming in a timely manner.

ACCESS AND INSPECTION OF RECORDS AND PROPERTY; SUBMISSION OF ITINERARIES.

The licensee is currently in travel status and did not submit a written itinerary to the Animal Care Regional Director prior to traveling with the animals.

The itinerary shall be received by the AC Regional Director no fewer than 2 days in advance of any travel and shall contain complete and accurate information concerning the whereabouts of any animal intended for exhibition at any location other than the person's approved site.

FACILITIES, GENERAL.

There is a string of lights that runs along the inside tent above the animal enclosures. The light bulbs are not covered and there are at least 4 light sockets that do not contain bulbs. In the event a bulb was to shatter, the material would fall into the animal enclosures. Open light sockets may be harmful to animals.

To be corrected immediately

Two fencing panels, one between the camels and the zebras, and one between the zebras and a horse are in disrepair. The one between the camels and the zebras has a top horizontal metal bar that has been bent downwards. The camel can now reach his head and neck into the zebra enclosure. The other fence panel has an area that is rusty and has broken apart. The current condition of these panels has the potential to result in injury to the animals. To be corrected by May 15, 2014

Animal housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.

3.131 (c)

SANITATION.

Animal enclosures are situated adjacent to an area where there is trash, including plastic items, lying on the ground. The items are close enough for the animals to reach or to blow into the pens. Trash should be placed away from animal housing areas and cleared as necessary to protect the health of the animals. To be corrected by April 24, 2014
