#### Bruce Zeman

What began as a landlord/tenant dispute over animals in 1997 had farreaching consequences for Augustus Club member Bruce Zeman. Rather than give up his dachshund, Nathan, Zeman took the landlord to court, and an animal rights advocate was born.

The case was settled, but during the process, Bruce discovered that companion animals were regarded as little more than property under New Jersey law. This angered him and motivated him to push for change. "To suggest he (Nathan) is a piece of property, or inanimate object, is ludicrous. property and spurred on by what he describes as "feudal" animal protection laws in New Jersey, Bruce became involved in several notable cruelty-toanimals cases, including

one in which a judge awarded him custody of Missy, a collie who had been suffocated when her "owner" no longer wanted her. Bruce had her buried in a pet cemetery near his home, and even now, he visits her as often as he can.

Shortly after burying Missy, Bruce embarked on a project that he considers to be one of the focal points of his life and one that will live on long after he is gone—to instill greater levels of respect, responsibility, and compassion toward the animals we share our lives with. Says Bruce, "By replacing the words 'animal owner" with 'guardian,' we can reconstruct the throughout the state in behalf of relationship between humans and animals—and help foster a change in people's attitudes toward animals. In other words, people will begin to recognize them as sentient beings with needs of their own, instead of obiects."

Although many other communities across the country had adopted guardian language in animal ordinances, none in New Jersey had done so. Bruce has changed that. On May 10, 2004, the Wanague mayor and Council unanimously adopted "Nathan's Law," named after Bruce's dachshund, which changed all "owner" references in the community's animal codes to "animal guardian."

Bruce considers the unanimous passage of "Nathan's Law" to be a significant chapter in animal welfare legislation in New Jersey. "In passing this progressive legislation, the mayor and council have proven this community is one where all family members are important and cherished. Pro-animal legislation is profamily legislation, and our leaders left no doubt Wanague is a great place to live and raise a family."

Bruce continues to speak animals and the ordinance, which is being considered in several other New Jersey municipalities. He is also completing his first book, A Boy and His Dog—Nathan's Story, which he hopes to have completed in the spring.

She also created a "Kala calendar" to raise money for and awareness of lost, abandoned, and mistreated animals. Two years later, Heidi discovered that Kala's mother was to have yet another litter, and she adopted Hula on Valentine's Day. ### Helping Animals 101: PETA's Course in Making the World a Better Place for Everyone

Helping Animals 101(HA101) is PETA's exciting seminar that's full of information and advice for people who want to turn their compassion into action to create a kinder society. Throughout the seminar, a team of PETA staff members presents strategies to change current systems and attitudes that lead to animal suffering. Our goal is to reduce cruelty and increase compassion by example and through education.

Many of society's problems stem from a lack of awareness about how our consumer choices negatively affect the world around us. By teaching attendees how to make compassionate consumer choices, HA101 presenters empower them by showing that positive, proactive steps are the most effective and easiest ways to create change.

PETA hosts an average of seven seminars a year in cities from coast to coast, with an average of 120 attendees per conference. Expert speakers give presentations on how to participants range in practice advocacy through effective letter-writing; how to work with local authorities and businesses to make changes in one's own community, how

to begin an activist group, how to use the media effectively and how to live more compassionately. In addition, participants learn how to use crueltyfree replacements for meat, eggs, and

are experienced activists and novice newcomers. Despite their differences, by the end of the seminar, a powerful sense of camaraderie exists among these many and varied people

Many attendees come because they heard from a friend how powerful and uplifting the sessions

are. HAIOI creates the alchemy that turns people's worry and feelings of powerlessness, frustration, depression, and intimidation into hope, empowerment, optimism, energy, and self-confidence. People often begin the HAIOI conferences sitting

alone, looking worried and tense. But by the end, everything has changed.

The room is buzzing with energy generated by people who are networking, exchanging ideas and plans, and, of course, talking about recipes!

Grassroots activists are the people who have changed our society—abolishing slavery, fighting for civil rights, securing women's right to vote, establishing worker protections, and creating environmental laws. HA101 fosters this spirit of strength, courage, and a "can do" attitude.

At PETA's headquarters, we hear from our past attendees on an almost daily basis. They write us and ask for recipes, literature to hand out at their schools (which we send for free), videotapes to show their coworkers, or feedback on a letter that they have written. It is gratifying and heartwarming to see these individuals gain more confidence and a hopeful outlook as they achieve their goals of creating positive change.

A Gift for Animals, Benefits for You— PETA's Charitable Gift Annuity



PETA has a well-established and successful charitable gift annuity program. Dozens of members have donated individual gifts to create a gift annuity in support of PETA's critical work. For them, establishing an annuity was a perfect way to make a significant gift to animals while securing regular and reliable income.

Charitable gift annuities are a simple agreement between you and PETA. In exchange for your gift to PETA of \$5,000 or more in cash or securities, PETA agrees to pay you and/or a designated beneficiary (called an "annuitant") fixed annual payments for life. These fixed annual payments are a percentage (an "annuity rate") of your gift as determined by the annuitant's age at the time of the gift and are backed by a reserve fund as well as by all PETA assets.

Besides the fixed annual payments, annuities can also provide significant tax benefits, such as a federal income-tax deduction in the year in which the gift is made and possible capital gains tax savings if your gift is appreciated securities. Moreover, charitable gift annuities offer very attractive rates of return. In many cases, annuity rates are higher than the best rates for savings accounts, certificates of deposit, or bonds.

However, gift annuities can also be an attractive option for those between the ages of 50 and 60 who want to secure a steady income for their retirement years and who can also benefit from a current-year tax deduction. By the terms of a deferred annuity, the longer that receipt of the payments is deferred, the higher the annuity rate and eventual payments.
