### Outdoor housing facilities.

There are four outdoor enclosures housing 13 adult collies. Three enclosures have three collies, and one enclosure has four collies. There is another outdoor enclosure that houses 4 juvenile, approximately 4 month old, collies. Each enclosure has a single igloo dog house contained in it.

Outdoor facilities for dogs must include one or more shelter structures that are accessible to each animal in each outdoor facility, and that are large enough to allow each animal in the shelter structure to sit, stand, and lie in a normal manner, and to turn about freely.

Additional shelters must be added to these enclosures to provide the animals contained shelter from the elements and to allow each animal in the shelter to sit, stand, and lie down freely. Shelters provide protection from rain, wind, and snow and are required for the comfort and welfare of the animals.

There are 13 adult collies, 4 juvenile collies, one Rottweiler, 2 Labrador retrievers and 8 shelties in outdoor enclosures with a single shelter. These shelters do not have wind and rain breaks at the entrance to the shelter.

Outdoor facilities for dogs must include one or more shelter structures with a wind break and rain break at the entrance.

A wind break must be added to the front of these enclosures to protect the animals from the rain and wind. Wind and rain breaks are necessary to keep animals warm and dry and prevent discomfort.

### 3.6(c)(4)

#### Primary enclosures.

The licensee has two dogs tethered inside an enclosure. An female black lab with id 998554 is tied with heavy chain to two 18" to 22" logs. The licensee stated this was done so that the dog could not jump out of the enclosure. There is a male chocolate lab with id 22498398 in the same enclosure that is tethered to the fence to prevent it from escaping the primary enclosure.

Permanent tethering of dogs is prohibited for use as primary enclosure.

Tethering is not allowed for use as the primary enclosure. Primary enclosures must be constructed to contain the animals without the use of tethering. The use of tethers can lead to injury or strangulation of animals and possible death. The female, black lab was unchained and placed inside the sheltered kennel at time of inspection.

#### Watering

In an outside enclosure in the second enclosure on the left with a 2 female collies with id's 17591, and 1532039, and 1 male collie with id 17590 there was no water in the water receptacle. I asked the licensee to fill the water receptacle and the dogs drank from 45 - 60 seconds straight.

Potable water must be continuously available to the dogs.

Direct

Water must be provided to dogs constantly to prevent dehydration and risk of disease.

### 3.11(a)

#### Cleaning, sanitization, housekeeping, and pest control.

The licensee is not cleaning feces from the outdoor primary enclosures. There is excessive feces in the enclosures of 13 adult collies, 1 adult Rottweiler, 4 juvenile collies, and 10 adult shelties. There is a single male French bulldog with id 8712041 housed in sheltered housing that also has excessive feces in the primary enclosure.

Excreta and food waste must be removed from primary enclosures daily to prevent soiling of the dogs contained in the primary enclosures, and to reduce disease hazards, insects, pests and odors.
