The floors in the pens had a 1 inch thick layer of fecal sludge in the front portions of the pens making them slick. This was observed by and discussed with REDACTED who explained that the establishment has future plans for better flooring in the new barn they are breaking ground on in April, but it could be a year or more until it is fully functional. The current flooring is less than ideal and could continue to be a concern until the new barn is functional.
