Attending veterinarian and adequate veterinary care (dealers and exhibitors).

An adult male Pomeranian named "Chewy" (last digits of m/c 9098) and an adult male Pomeranian named "Alfie" (last digits of m/c 6373) had dried fecal matter attached to the hair around their anuses. Fecal matter attached to hair can result in matting, skin irritation, and can even hinder bowel movements. The licensee must remove the fecal matter from these dogs and must establish an effective program of haircoat maintenance.

An adult female Poodle named "Curly" had excessively matted hair along her back, on her tail, and down her back legs. Matted hair can result in skin problems, can be painful, and can compromise the hair's ability to provide protection from the heat or cold. The licensee must remove the matted hair from this animal and must establish an effective program of haircoat maintenance.

Primary enclosures.

The gravel in four outdoor enclosures housing a total of 10 adults and 5 puppies were entirely wet. All of the dogs were wet and dirty from walking on the wet gravel and dirt. Wet and dirty dogs can be uncomfortable and may have difficulty staying warm. The licensee must ensure that enclosures have enough gravel to allow adequate drainage and to keep the dogs dry.

Inspection Report

The outside pens of two enclosures of the sheltered building (housing a total of 4 adult dogs) had standing water. The inside portion of one enclosure containing 3 adult dogs had an excessive amount of fecal material which had been smashed flat from the dogs walking in it. Standing water and fecal material can contain microorganisms that can affect the health of the dogs. The licensee must ensure that standing water is removed from the primary enclosures.

3.11(b)(1)

Cleaning, sanitization, housekeeping, and pest control.

An enclosure housing 3 adult dogs had excessive dirt and grime on the entire walls. The dogs currently inside the enclosure were short and could not reach the top of the walls. The licensee stated that the enclosure previously contained a large dog and that the enclosure had not been cleaned prior to the addition of the small dogs. Dirt and grime can harbor diseases that can affect the health of the dogs. The licensee must clean and sanitize used primary enclosures before they are used to house other dogs.
