** A six year old date of birth 12-21-17, female black and silver Poodle, micro-chip 2194966. Had a buildup of dark matter on the teeth and red gums.

** A five year old, date of birth 12-02-18, male, black and Tan Yorkie, micro-chip 2874016. Had a buildup of dark matter on the teeth and red gums.

A buildup of dark matter and red gums can lead to dental disease, cause pain and tooth loss. The dogs listed must be seen by a veterinarian to determine if treatment is necessary. The licensee must follow the dental plan to provide for the health and well-being of the animals. All licensees must use appropriate methods to prevent, control, diagnose and treat diseases.
