Attending veterinarian and adequate veterinary care (dealers and exhibitors).

***Loose stool was noted in the outdoor enclosure that housed two Bengal cats, "Big Mac" (2-year-old male) and "Coco" (3-year-old female). Changes in the consistency of stool may indicate several medical conditions related to parasites, diet, stress, or more serious issues. The licensee must have the animals examined by a veterinarian to determine an appropriate plan for diagnosis and treatment.

Correct by: July 27, 2023

***A 3-year-old female Bengal cat named "Topaz" was observed by local officials on 19 July 2023 as underweight and appeared dehydrated. The facility took the animal to a veterinarian that day, and the assessment showed an infection and dehydration. In addition, the cat was found to be under the ideal weight.

Corrected prior to the inspection.

***Expired medications were noted in a downstairs cabinet. A box of Revolution expired on 03/2023, Lutalyse Injection 5mg/ml expired on 5/1/2023, and Gabapentin 100 mg/ml expired on 7/21/2021. Expired medications should not be used as the efficacy and safety cannot be assured. Such medications should be segregated, labeled as expired, and disposed of in a proper manner.

3.1(b)

Housing facilities, general.

Accumulations of discarded materials, trash and other waste were present in various areas of the housing facility. Several overflowing garbage receptacles were noted in the laundry room where animal food was stored. The sink was also filled with utensils waiting to be cleaned. In addition, numerous soiled litter boxes awaiting cleaning were found stacked in another room. Animal areas must be kept neat and free of any accumulation of trash, waste material, and other discarded materials. These attract rodents, insects and other pests, and contribute to odor.

Cleaning, sanitization, housekeeping, and pest control.

The enclosure that housed two Bengal cats ("North" and "Maple") had an exercise wheel that was soiled with fecal material. Stool was also present on the floor of the enclosure near the wheel. Excreta must be removed from primary enclosures daily to prevent accumulation of feces and soiling of the cats, and to reduce disease hazards, insects and odors.

3.11(c)

Cleaning, sanitization, housekeeping, and pest control.

Accumulations of trash and other discarded materials were present in several places on the ground in front of the facility. Numerous flies were also noted throughout the facility. Premises must be kept free of accumulations of trash, junk, waste products, and discarded matter to help control rodents, insects, and other pests.
