Dear Dr. Ramasubramanian,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 8, 2021 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Virginia following up on an initial July 21, 2021 notification by email.

According to the information provided, this Office understands that the University of Virginia Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: failure to adhere to the IACUC-approved protocol and failure to maintain appropriate animal-related records. The final report states an IACUC member identified two cages of animals (mice) with incomplete surgery cage cards during an assessment in the vivarium. The cards were incomplete for post-operative (post-op) observations and administration of analgesia.

The matter was discussed by the IACUC and determined to be a significant deficiency and deviation from the protocol and IACUC policy. Per the report, it appeared the surgeon was not adequately trained to complete the surgery cage cards, and it was later confirmed that post-op analgesia had not been administered. In response, the committee sent a letter to the principal investigator (PI) informing them of the incident and a corrective action plan was requested by the IACUC.

The PI responded to the IACUC with the following corrective action plan:

- The PI will train all new animal handlers assigned to perform surgical experiments to ensure compliance and they will not be permitted to work independently until competency is demonstrated.
- A senior animal handler will visit the vivarium on a routine basis and examine surgery cage cards for completion.
- The laboratory will review portions of the animal use protocol on a routine basis to ensure familiarity with approved procedures.
- The analgesic regimen in the approved protocol will be followed until modifications are submitted and approved.
- The laboratory consulted with the Attending Veterinarian to determine if modifications to the protocol were warranted.

The IACUC determined the corrective action plan provided by the PI was appropriate and concluded no further action was necessary.

It is noted that this research is supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the University of Virginia has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

University of Virginia Animal Welfare Compliance Report

PHS Assurance # A3245-01

The Institutional Animal Care and Use Committee found the following compliance issue while performing an assessment in the vivaria. A preliminary email notification was sent to the OLAW Division of Compliance Oversight by Angela Gamble, Director of the Office of Animal Welfare. Dr. Axel Wolff acknowledged receipt. It was understood that a full report would be submitted following an IACUC investigation. This document is a summary of the incident, actions taken, and final resolution.

UVA Compliance Case #: 2021-N

Nature of Incident(s):	Failure to adhere to approved protocol resulting in inadequate post- operative care; failure to maintain appropriate animal-related records (mice)
Summary of Incident:	During an assessment in the vivaria, a member of the Institutional Animal Care and Use Committee (IACUC) observed two cages of animals with incomplete surgery cage cards. The cards were incomplete for post-operative observations and analgesia administration.
Action taken by IACUC:	The IACUC discussed the incident at the Program Review meeting and determined that the incident was a significant deficiency because of the <i>potential</i> impact on animal welfare and the deviation from the protocol and IACUC policy. It appeared that the surgeon was not adequately trained to complete the surgery cage cards, and it was unclear if post-operative analgesia was administered in accordance with the approved protocol. The IACUC sent a letter to the PI notifying him of the deficiency and required a written corrective action plan to prevent reoccurrence.
Action taken by PI:	The PI responded to the IACUC concerns and indicated that the animal handlers were retrained on the proper way to complete surgery cage cards and reviewed the IACUC surgical policy. The PI will train all new animal handlers assigned to perform surgical experiments to ensure compliance and they will not be permitted to work independently until competency is demonstrated. A senior animal handler will visit the vivarium on a routine basis and examine surgery cage cards for completion. The laboratory will review portions of the animal use protocol on a routine basis to ensure familiarity with approved procedures. The analgesia had not been administered at the frequency listed in the approved protocol. The analgesic regimen in the approved protocol will be followed until modifications are submitted and approved. The laboratory consulted with the Attending Veterinarian to determine if modifications to the protocol were warranted.

Action taken by IACUC:	The IACUC felt that the PI responded appropriately and no further action was deemed necessary. This incident occurred during the COVID-19 pandemic which may have contributed to the occurrence. Upon examination of the colony with respect to the corrective action plan success, the Office of Animal Welfare found all cages to be compliant.
Decision/Resolution:	The IACUC accepted the corrective action plans as submitted by the PI and considered the incident resolved.

Dear OLAW Division of Compliance Oversight,

This is to provide preliminary notification that the University of Virginia IACUC (PHS Assurance #A3245-01) identified several significant deficiencies during an assessment of the program. The UVA tracking numbers are listed below. The issues with two tracking numbers involve two researchers. Each issue is currently under investigation and review by the IACUC. We are working towards resolution and will send a separate compliance report for each of the bulleted points once resolved.

- 2021-H and 2021-I: condition that *potentially* jeopardized the health or well-being of animals resulting in the *potential* for harm or death (neonatal mice). This single event has two IACUC Tracking Numbers due to the dual involvement of two separate investigators.
- 2021-J and 2021-K: condition that potentially jeopardized the health or well-being of animals resulting in the
 potential for harm or death (neonatal mice) This single event has two IACUC Tracking Numbers due to the dual
 involvement of two separate investigators.
- 2021-N: post-operative care was inadequate and appropriate animal records were not maintained
 - 2021O: condition that had the *potential* to jeopardize the health or well-being of an animal (mice)
