Dear Dr. Ramasubramanian,

The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your September 8, 2021 document reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals at the University of Virginia following up on an initial July 21, 2021 notification by email.

According to the information provided, this Office understands that the University of Virginia Animal Care and Use Committee (ACUC) determined that instances of noncompliance occurred with respect to: conditions that had the potential to jeopardize the health and/or well-being of an animal. An IACUC member identified a mouse with a noted unresolved medical condition during an assessment in the vivarium. While the condition was recorded on the cage card, it had not been reported to the veterinary staff. In response, the animal was immediately evaluated and found to be bright, alert, and responsive. However, it is stated the animal should have been euthanized for the chronic unresolved condition.

The matter was discussed by the IACUC and determined to be a significant deficiency and programmatic issue since it had the potential to affect any animal at the institution. The IACUC requested a corrective action plan from the Attending Veterinarian (AV) regarding the deficiency. The AV met with the vivarium supervisor, and it was revealed the supervisor was unaware that the condition should have been reported to the veterinary staff for evaluation. It is also stated the chronic condition could not be effectively treated and that the laboratory should have been notified that euthanasia of the animal was necessary. It is understood the vivarium supervisor was informed that all animal health related conditions must be reported to the veterinary staff for evaluation. Per the report, the IACUC determined the AV responded appropriately and no further action was necessary.

It is noted that this animal was not supported by PHS funding. Based on its assessment of this explanation, OLAW understands that the University of Virginia has implemented appropriate measures to correct and prevent recurrences of these problems and is now compliant with provisions of the PHS Policy.

We appreciate being informed of these matters and find no cause for further action by this Office.

## University of Virginia Animal Welfare Compliance Report

PHS Assurance # A3245-01

The Institutional Animal Care and Use Committee found the following compliance issue while performing an assessment in the vivaria. A preliminary email notification was sent to the OLAW Division of Compliance Oversight by Angela Gamble, Director of the Office of Animal Welfare. Dr. Axel Wolff acknowledged receipt. It was understood that a full report would be submitted following an IACUC investigation. This document is a summary of the incident, actions taken, and final resolution.

## UVA Compliance Case #: 2021-O

Nature of Incident(s):	Condition that had the potential to jeopardize the health or well-being of an animal (mouse).
Summary of Incident:	During an assessment in the vivaria, a member of the Institutional Animal Care and Use Committee (IACUC) observed one animal with a noted unresolved medical condition. The condition was noted on the cage card but had not been reported to the veterinary staff. The animal was immediately evaluated by a veterinarian, and found to be bright, alert, and responsive; however, the animals should have been euthanized for the chronic unresolved condition.
Action taken by IACUC:	The IACUC discussed the incident at the Program Review meeting and determined that incident was a significant deficiency because of the failure to report the animal health condition to the veterinary staff which then lead to inadequate veterinary care in addressing the chronic unresolved condition. Although only one animal was found, the IACUC considered it a programmatic issue that had the potential of affecting any animal at the institution (i.e., federally funded, institutionally funded). The IACUC wrote to the Attending Veterinarian (AV) describing the deficiency and required a response in writing with a corrective action plan to prevent reoccurrence.
Action taken by AV:	The AV responded with a corrective action plan. The AV met with the vivarium supervisor regarding the note on the cage indicating the medical condition. The vivarium supervisor was unaware that the condition should have been reported to the veterinary staff for evaluation. The AV explained to the vivarium supervisor that the veterinary technical staff should have had an opportunity to review the specific conditions. The chronic unresolvable condition that was noted during the assessment was identified as a condition that cannot be effectively treated; therefore, the laboratory should have been notified that the animal must be euthanized. The vivarium supervisor was told that all animal health related conditions must be reported to the veterinary staff for evaluation.

Action taken by IACUC:	The IACUC felt that the AV responded appropriately and no further action was deemed necessary.
Decision/Resolution:	The IACUC considered the incident resolved with no fault to any grant holder.
