Attending veterinarian and adequate veterinary care (dealers and exhibitors).

***The 6 yr old female Dachshund "Fallon"(chip #000010547361) is very thin (BCS 3/9), her vertebrae and ribs are easily palpated with very little fat observed around her abdomen. Fallon has a large accumulation of a gray colored material on her upper and lower teeth on both sides of her mouth, her gums in these areas are reddened and swollen. Allowing accumulations of tartar can interfere with the dogs ability to eat and drink inhibiting proper nutrition and it can cause the development of infections of the gums that may lead to additional illness. Fallon's dental record indicates she was last checked in April 2023 and was to be watched but there is no follow-up exam recorded.

Fallon must be examined and appropriate care provided to protect her health and well-being.

Time and method of identification.

***There is one enclosure housing a female dachshund with seven puppies and another housing a female dachshund with one puppy. There are two enclosures containing a single dachshund puppy each. There is no identification for the puppies provided on the identification boards above the enclosures, cage cards, or by any other means. All puppies require identification as required in this section. If cage cards are used to identify the puppies they must have the puppies individual number, and means of identification such as distinctive colors or markings, sex, etc. The cards must be attached to the front of the enclosure.

***There are discarded empty bags, spilled food, antifreeze containers, etc dispersed among the bags of dog food. Accumulations of trash and waste material and chemicals increase the risk of food contamination and the presence of vermin or problems with pest control. The food storage area must be kept free of clutter with items properly stored to

Attending veterinarian and adequate veterinary care (dealers and exhibitors).

The male Dachshund "Esau" (chip number*54053), and the male Dachshund "Israel" (chip number ****52076), have moderate to severe tartar primarily on their canines. Esau was examined in March and a follow-up examination has not been scheduled. As Esau's condition has progressed, he is now in need of a full dental. There is no record indicating Israel received a dental examine recently. Israel shall be examined by the veterinarian and provided a dental cleaning. Correct by May 31, 2023.

3.1(a)

Housing facilities, general.

***While waiting for the licensee to arrive on property USDA observed a cream colored long haired Dachshund, later identified as Hannah, clinging to the very top of the gate to her outdoor run about to do over the gate. Discussions with the licensee indicate Hannah has a history of escaping from her enclosures. An enclosure must be provided for Hannah that will keep her secured within thereby protecting her from possible injury and loss. Correct by May 24, 2023.

3.1(c)(1)(i)

***The indoor and outdoor runs have coated wire gates. Approximately 15 percent of the gates observed have an excess build up of rust, two of the gates have corrosion along the bottom edge. There are two crates in the buildings that are

coated with rust. The powdery rust rubs off on your hands when touching the crates. The accumulation of rust inhibits effective cleaning and sanitation and depending on the severity may decrease structural strength. The gates and crates shall be repaired or replaced to allow effective cleaning and sanitation, minimize possible disease hazard, and ensure the enclosures are structurally sound. Correct by June 17, 2023.

3.3(e)(1)(iii)

Sheltered housing facilities.

***There are three sheets of wood located over the front end of three of the dog enclosures. The wood covers the top of approximately 1/3 of the front of the enclosure. The wood was placed there to temporarily hold supplies while in use as well as support the dogs when handled above their enclosure. The dogs have contact with the boards when jumping or placed on them. These boards are not impervious to moisture and cannot be properly cleaned and sanitized increasing the risk of disease hazard. All walls, boxes, houses, dens, and other surfaces in contact with the animals must be impervious to moisture to allow effective cleaning and sanitization thereby decreasing the risk of possible disease hazards. There are three dachshund puppies under 16 weeks of age and from two separate litters housed in the same run. The puppies have no identification. The puppies shall be identified by an acceptable method as defined in this section.

Housing facilities, general.

In the last two runs in the new building the floors are covered with ceramic tile. There are three dachshunds housed in each of the enclosures. There is an accumulation of excreta on the floors that is getting smeared around while the dogs run through the enclosure. These enclosures shall be cleaned at a sufficient frequency to prevent accumulation and ensure the dogs have the freedom to avoid contact with excreta. Correct by August 3, 2021.

3.13(a)(4) Direct

Veterinary care for dogs.

The male chocolate/tan piebald dachshund microchip #003796602 has severe tartar on his upper canines. Female red dachshund chip #021218093 has extensive tartar build up on her canines and pre-molars. Her gums are inflamed and receding. The dachshund also has overgrown toenails which are causing her toes to deviate which if allowed to continue

***Pens 5, 6 and 7 in the new kennel and some of the gates on the outside have wire or hardware cloth that is severely rusted with sections of corrosion that have left sharp jagged points which may cause puncture wounds or injuries when the dogs come in contact with them. All corroded jagged wire shall be repaired or removed to prevent such injuries and allow proper cleaning and sanitation.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

***The inside enclosures in the whelping house have newspaper that is soaked and soiled. The dogs and puppies in these enclosures are wet. Three enclosures have no or minimal dry surface area in the whelping box for the puppies and dogs. The outside portions of these enclosures have wood chips where there are excessive accumulations of excreta in the wood chips indicating the excreta has not been removed daily or the soaked wood chips removed or replaced at a frequency necessary to prevent the excessive accumulation or prevent soiling of the dogs within the enclosure.
