Medications and veterinary supplies lose their effectiveness when expired and may effect treatment outcome. Supplies of drugs and other medical supplies and must be maintained within expiration date to ensure that adequate veterinary care is provided . CORRECTED DURING INSPECTION

#### HOUSING FACILITIES, GENERAL.

There are open bags of food enrichment items (pretzels and fruit loops) in Bay 8 CK . Open bags of food allow for the contamination from pests and deterioration of the food.
