The Office of Laboratory Animal Welfare (OLAW) acknowledges receipt of your October 24, 2023 letter reporting an instance of noncompliance with the PHS Policy on Humane Care and Use of Laboratory Animals within the animal care and use program at the University of Virginia. Your letter supplemented the information contained in an initial email report to this office on September 28, 2023. According to the information provided, OLAW understands that two mice received expired anesthetic to immobilize them for a laboratory procedure. The anesthetic expired 15 days prior to use. The post-doctoral student responsible for labeling and disposal of controlled substances had recently left the institution and the graduate student who used the expired drug was not aware of the expiration date. The mice involved in this incident were supported by PHS funds.

Corrective and preventive measures were initiated. The principal investigator (PI) and all authorized users were retrained on the labeling, usage documentation, and disposal practices for controlled substances. All users were reminded that the use of expired substances is never permitted. The PI instituted annual retraining of animal handlers on proper use and disposal of controlled substances. Further, the expiration dates of substances will be placed in a shared laboratory calendar with notification reminders to dispose of expired substances and mixtures.

OLAW appreciates the consideration of this matter by the University of Virginia, which was consistent with the philosophy of institutional self-regulation. Based on the information provided, OLAW is satisfied that appropriate actions have been taken to investigate this incident and prevent recurrence. However, in future reports please indicate whether the animals were negatively affected by the noncompliance.

We appreciate being informed of this matter and find no cause for further action by this office.

University of Virginia Animal Care and Use Compliance Report PHS Assurance # A3245-01

The Institutional Animal Care and Use Committee (IACUC) discovered the following compliance issue and found that it was associated with NIH funds. A preliminary email notification was sent to the OLAW Division of Compliance Oversight by the Director of the Office of Animal Welfare. Devora McCoy, Program Analyst, acknowledged receipt. It was understood that a full report would be submitted following IACUC review. This document is a summary of the incident, actions taken, and final resolution.

UVA Case #: 2023-E OLAW Case #: A3245-4Z

Nature of Incident(s):	Administration of expired anesthetic
Summary of Incident:	During the semi-annual facility inspection, a member of the Institutional Animal Care and Use Committee (IACUC) found a bottle of expired anesthetic and upon further review determined that the substance was used beyond the expiration date. According to the controlled substance usage documentation, a working solution of anesthetic was made using the expired anesthetic stock solution and two mice were administered the anesthetic mix. The solution was used approximately 15 days past the expiration date. The anesthetic was used to immobilize the animals for a laboratory procedure.
Action taken by IACUC:	The IACUC discussed the incident at a convened meeting and determined that the incident was a significant deficiency because of the <i>potential</i> impact on animal welfare. The IACUC sent a letter to the PI notifying them of the deficiency and reminded them that using expired anesthesia for any purpose is prohibited. The PI was required to dispose of the expired material and provide a written corrective action plan to prevent reoccurrence.
Action taken by PI:	The PI responded to the IACUC concerns and reported that the expired anesthetic and all solutions made with the expired anesthetic were immediately labeled for disposal. The PI indicated that the post-doc responsible for controlled substance labeling and disposal left the institution suddenly and the graduate student using the controlled substance was not aware of the expiration date. All authorized users were provided immediate retraining on the following: the IACUC policy for labeling and monitoring vials of anesthetic; reminded that the use of expired substances is never permitted; and reviewed methods for completing usage and disposal documentation. The PI instituted annual retraining of animal handlers at the start of every fall semester on proper usage and disposal of controlled substances. The expiration dates of substances will be placed in a shared laboratory calendar with notification reminders to dispose of expired substances and mixtures.

Action taken by IACUC:	The IACUC felt that the PI responded appropriately; however, the Committee required that the PI complete one-on-one training with the director of the Office of Animal Welfare on the labeling, usage documentation, and disposal practices for controlled substances.
Decision/Resolution:	Following the required training, the IACUC felt that no further action was deemed necessary and accepted the corrective action plans as submitted by the PI. The IACUC considered the incident resolved.

Dear OLAW Division of Compliance Oversight,

This is to provide preliminary notification that the University of Virginia IACUC (PHS Assurance #A3245-01) identified three significant deficiencies during the semi-annual inspection of the program. The UVA tracking numbers are listed below. Each issue is under review by the IACUC, and they are working towards resolution. The IO will send a separate compliance report for each of the bulleted points once resolved.

• (OLAW case number A3245-4X)- 2023-C: failure to maintain appropriate animal-related husbandry records. A gap in the animal husbandry records was identified in one rodent room

- (OLAW case number A3245-4Y)- 2023-D: failure to monitor animal post-procedurally as necessary to ensure well-being. Rodent surgery cage cards were incomplete from two different surgeons on the same animal use protocol.
- (OLAW case number A3245-4Z)- 2023-E: researcher inadvertently administered expired anesthetic to rodents
