Dear Dr. Morse:

I am writing on behalf of People for the Ethical Treatment of Animals (PETA) and our more than 9 million members and supporters to request that your office investigate possible noncompliance with the Public Health Service Policy on Humane Care and Use of Laboratory Animals (PHS Policy) and the *Guide for the Care and Use of Laboratory Animals* (the *Guide*) related to the treatment of animals at the Oregon National Primate Research Center, Oregon Health & Science University's (OHSU; PHS-Approved Animal Welfare Assurance #D16-00195) West Campus, located at 505 NW 185th Ave. in Beaverton, Oregon.

According to [an inspection report dated March 4, 2025](#), and posted last week by the U.S. Department of Agriculture (USDA), a young Japanese macaque died a painful death from sepsis after her symptoms were ignored and she was denied necessary medical care. The report also details that dozens of other Japanese macaques were confined for approximately 96 hours in cages that failed to meet the minimum space requirements mandated by the Animal Welfare Act and its implementing regulations. Inspectors noted that "several animals appeared too large for the enclosures they were housed in." Additionally, areas confining rhesus macaques were described as rusted, unsanitary, and in a state of disrepair.

It appears to us that the issues raised in the USDA's report—specifically, the failure "to ensure that timely and accurate information is conveyed to the responsible veterinarian about issues associated with animal health, behavior, and well-being, and that appropriate treatment or euthanasia is administered";¹ the failure to "provide sufficient space ... required to meet [animals'] physical, physiologic, and behavioral needs";² and the failure to ensure that "enclosures [are] kept in good repair to prevent escape of or injury to animals, promote physical comfort, and facilitate sanitation and servicing"³—indicate noncompliance with PHS Policy and the *Guide*. Moreover, it does not appear that OHSU self-reported these lapses to OLAW.

We urge your office to thoroughly investigate the failures detailed in the USDA inspection report and assess whether OHSU has complied with its obligation to


