Requirements and application.

The facility has been operating and exhibiting regulated animals to the public since March 18, 2025 without a USDA license. Although this site has applied for a license, the precensing process has not been completed and no license has been issued. Allowing the public to have interactions with animals without a Class C Exhibitors license puts the animals and the public at risk and is a violation of the federal Animal Welfare Act.

2.131(c)(1)

Handling of animals.

On March 22, 2025, a patron took their child in to have an interaction with the facility's rabbits. A staff member accompanied the patrons during said interaction. The child was petting one of the rabbits, as directed by the staff member, and the child was bitten on her left hand by the wrist. The facility completed an incident report about this bite.

During this public exhibition, the facility failed to protect the public from harm.

During public exhibition, any animal must be handled so there is minimal risk of harm to the animal and to the public, with sufficient distance and/or barriers between the animal and the general viewing public so as to assure the safety of animals and the public.

This is a First Pre-License Inspection for a Class C license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspection(s) by June 7, 2025 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Pre-License Inspection.

Conducting regulated activities without a valid USDA license is a violation of the Animal Welfare Act.
