Procurement of dogs, cats, and other animals; dealers.

The licensee stated that 2 guinea baboons were purchased from an individual in Seagoville, TX on August 25, 2025 and the seller does not have a USDA license. Animals sold by individuals who are required to have a USDA license, but does not a valid USDA license may suffer from poor welfare due to lack of compliance with Animal Welfare Act (AWA) regulations. No dealer or exhibitor shall knowingly obtain any dog, cat, or other animal from any person who is required to be licensed, but who does not hold a current, valid, and unsuspended license.

Housing facilities, general.

An olive baboon was observed chewing on hair tie inside its enclosure. Ingestion of the material could potentially cause injury to the animal. Housing facilities for nonhuman primates must be designed and constructed so that they are structurally sound for the species of nonhuman primates housed in them. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

Corrected at time of inspection 29 SEPT 2025

A white headed capuchin was observed reaching outside his primary enclosure flipping open the covers for an electrical outlet. The opened electrical outlet is a potential source of injury to the animals. Housing facilities for nonhuman primates must be designed and constructed so that they are structurally sound for the species of nonhuman primates housed in them. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

Inspection Report

In the primary enclosures for the ring tailed lemurs, there were many rats seen inside the enclosure with the nonhuman primates. The presence of rats is a potential disease hazard to the animals as these rodents can be carriers of disease and parasites. An effective program for control of mammals that are pests, must be established and maintained so as to promote the health and well-being of animals and reduce contamination by pests in the animal areas.

Facilities, general.

In the large outdoor enclosure housing sika deer, blackbuck, fallow deer, goats, sheep, and zebra, there are several railroad ties that have metal rods with sharp points exposed to the animals. This is a potential source of injury to the enclosed animals. The railroad ties with sharp extending rods need to be removed. All housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury.
